1. Introduction

Advanced Functional Medicine, LLC ("Company," "we," "us," or "our") operates MasterIFM ("Service"). This Privacy Policy explains how we collect, use, and protect your information when you use the Service.

2. Information We Collect

a. Information You Provide

We may collect:

- Name
- Email address
- Payment information (processed via third-party providers)
- Account login credentials
- Any information you submit through the Service

b. Automatically Collected Information

We may automatically collect:

- IP address
- Device type and browser
- Usage data (pages viewed, time spent, activity)
- Login timestamps and access patterns

c. Third-Party Platform Data

The Service is hosted by a third-party platform, which may collect and process data according to its own privacy policies.

3. How We Use Your Information

We use your information to:

- Provide and operate the Service
